

OFF-LICENCE

Sections 17 to 20 and 64 Sale and Supply of Alcohol Act 2012

ARLA Ref: **50/OF/006/2022**

DLC Ref: **OF134**

Pursuant to the Sale and Supply of Alcohol Act 2012 ("the Act"), **Foxy Boxy Ltd** (the licensee) is authorised to sell and supply alcohol on the premises situated at **23 Vanguard Street, Nelson** and known as "**Foxy Boxy**" to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

Section 40 of the Act applies to this licence, and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. **HOURS** –

a. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 24 hours per day as online sales

b. No alcohol sold is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day.

c. Alcohol must not be delivered to the buyer between 11:00pm on any day and 6:00am the next day.

2. **RESTRICTIONS** –

a. The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed.

b. The licensee must take reasonable steps to verify that the buyer of the alcohol, sold by remote means, is not under the purchase age.

c. Alcohol may only be sold as an appropriate compliment to gifts of the type described in the application and presented in the form of a gift box.

d. Alcohol may also be sold individually in a gift box that is branded as a corporate gift with a minimum price of \$50.


3. **SIGNAGE**

The licence holder's name, the licence number and the date on which the licence expires must be displayed on any internet site for remote sales, in any catalogue and printed on every receipt issued for alcohol sold remotely.

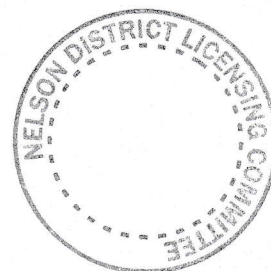
DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force until the expiry date or if an application for renewal is received before it expires – until 3 years after the expiry date.
